**CONDITIONS GOVERNING REPRODUCTION OF WORKS  
IN THE COLLECTIONS OF THE SOCIETY OF THE CINCINNATI**

1. Unless otherwise indicated, the Society makes no representation regarding copyright of the materials provided to the applicant. The applicant is responsible for ensuring compliance with federal copyright law.
2. Permission is granted for a **one-time use** of the reproduction for the purpose described in this request. Any use of the reproduction of the work(s) other than the one-time use for which permission has been granted by this form must be requested separately in writing from the Society.
3. The one-time use of the reproduction of the work must be accompanied by the words of credit: "The Society of the Cincinnati, Washington, D.C." Additions or alterations to this credit line may be required by the Society.
4. In addition to the words of credit required by the preceding paragraph, if the Society owns the copyright to the work, proper notice of copyright must be affixed adjacent to the reproduction of the work. Proper notice of copyright shall consist of: (1) the symbol ©, the word "Copyright," or the abbreviation "Copr."; and (2) the year of first publication of the work; and (3) the name of the owner of the copyright, "The Society of the Cincinnati."
5. Each work or portion of a work for which permission to reproduce is granted must be reproduced in full. Unless specified in this form, requests to crop, bleed, tone, silhouette, or overprint an image must be received in writing with a layout of the proposed alterations prior to display or publication.
